Find out if you qualify

- 1 You must heat your home with a natural gas, oil, propane boiler/furnace OR wood stove.
- 2 If you are an Enbridge customer and have a valid Enbridge account number in good standing OR if you heat your home with oil, wood or propane—you must provide a current tax bill for the property.
- 3 You must use an Enbridge approved Certified Energy Auditor (CEA).
- 4 You must **complete at least two** of the following Home Energy Upgrades listed to the right as recommended by the CEA and achieve a minimum 15% annual fuel savings.*
- 5 You must complete pre and post energy audits from the same Enbridge approved CEA by **December 31, 2017**.

To find out if you can reach a minimum of 15% in annual natural gas or alternative fuel savings, a pre and post home energy audit is required by a Program approved Certified Energy Auditor (CEA). Please contact one of the Enbridge pre-approved Certified Energy Auditors listed above for further information about this Program. The Home Energy Conservation Program is only available for residential detached homes, towns and semis – no multi-residential buildings or condos.
